ORDER

Before the Court is the Motion for leave of Court to Serve Summons by Publication filed by the petitioners, through counsel, alleging that is per Process Server's Return dated August 9 2020 personal service of summons set in as per Process Server's Return dated August 19, 2020, personal service of summons, peti-tion and its annexes to respondent Carmen's dry Goods Inc. was not served as there was no ad-

dress given or provided in the petition and in the Notice of Levy and Certificate of Sale. Peti-tioners also contends that considering that respondent cannot be located and its whereabouts is unknown and cannot be ascertained by dili-gent effort, there is a need for the service of summons by publication in accordance to Section 16, Rule 14 of the Rules of Court.

The Motion is meritorious.

Section 16, Rule 14 of the Rules of Court, as

amended provides that:

"Section 16. Service upon defendant whose

identity or whereabouts are unknown.

In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendar days from the commencement of the action, service may, by leave of court, be effected upon him by publication in a newspaper of general circulation and in such places and for such time as the court may or-

Any order granting such leave shall specify a reasonable time, which shall not be less than sixty (60) calendar days after notice, within

which the defendant must answer."

In the instant case, despite diligent efforts in the instant case, despite diligent errors exerted, summons was not served to respondent Carmen's Dry Goods Inc. as there was no address given or provided in the petition. In the case of Santos, Jrvs. PNOC Exploration Corporation, the Supreme Court explains that in any option, the despite in present in the supreme Court explains that in any option whether in present in the supreme court explains that in any action whether in personam, in rem, quasi in rem, where defendant is designated as an unknown owner, or the like, or whenever his whereabouts are unknown and cannot be ascertained by diligent inquiry, service of summons upon said defendant by publication in a newspaper of general circulation is allowed. Pertinent excerpts of the deceision read:

Since petitioner could not be personally served with summons despite diligent efforts to locate his whereabouts, respondent sought and was granted leave of court to effect service of summons upon him by publication in a newspa-per of general circulation. Thus, petitioner was properly served with summons by publication. Petitioner invokes the distinction between an

action in rem and an action in personam and claims that substituted service may be availed of only in an action in rem. Petitioner is wrong. The in rem/in personam distinction was significant under the old rule because it was silent as to the kind of action to which the rule was applicable. Because of this silence, the Court limited the application of the old rule to in rem actions

only.

This has been changed. The present rule ex pressly states that it applies "[l]in any action where the defendant is designated as an unknown owner, or the like, or whenever his whereabouts are unknown and cannot be ascertained by diligent inquiry." Thus, it now applies to any action whether in personam, in rem or quasi in rem. xxx

WHEREFORE, foregoing premises considered, the Motion for Leave of Court to Serve Summons by Publication is hereby GRANTED. Accordingly, petitioners are allowed to serve summons by publication to respondent Carmen's Dry Goods Inc. It is given a reasonable period of sixty (60) days after notice within which to of sixty (60) days after notice within which to

of sixty (60) days after notice within wine. file its Answer or any responsive pleading. Let Alias Summons be issued and served by publication once a week for two (2) consecutive weeks in a newspaper of general circulation in the Philippines together with this Order at the expense of the petitioners. Moreover, let copy of the summons together with the Petition and all its attachments as well as this Order be sent by registered mail to respondent Carmen's Dry Goods Inc. at its last known addreses.
