ORDINANCE NO. 1092, Series of 2023

AN ORDINANCE CREATING PUBLIC UTILITIES COORDINATING COUNCIL (PUCC) TO MONITOR THE INFRASTRUCTURE ACTIVITIES AND PROJECTS OF ALL PUBLIC UTILITIES IN VALENZUELA CITY AND ENSURE THEIR PROPERAND SAFE MAINTENANCE.

SECTION 1. Title. - This Ordinance shall be known as the "Public Utilities Coordinating Council Ordinance of Valenzuela City"

SECTION 2. Prescribed Act. - The Public Utilities Coordinating Council is hereby created which will monitor all construction/installation of transmission and distribution lines of electricity utilities, water and sewerage utilities, telecommunications, internet, closed-circuit television (cctv), and cable antenna television utilities operating within Valenzuela City.

SECTION 3. Definition of Terms

SECTION 4. Composition of the Public Utilities Coordinating Council (PUCC).

SECTION 5.-Duties, Functions, and Responsibilities of Public Utilities Coordinating Council (PUCC).
