AN ORDINANCE ALLOWING ONE-WAY TRAFFIC SCHEME AND ONE-SIDE PARKING ALONG MENLO SUBDIVISION, A. MARCELO STREET, BARANGAY DALANDANAN, VALENZUELA CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

SECTION 4. EXCEPTIONS. – This ordinance shall not apply to:

Law enforcement vehicles, emergency vehicles, including ambulances, responding to law enforcement business, emergencies, or fire.

b) Official City/Barangay vehicles parked to conduct official business, including, but not limited to, delivery of public service, conducting road repair or engineering works and inspections.

c) Private vehicles when performing urgent tasks or when necessary for reasons of health, physical disability, or unique hardship only for the period necessary to accomplish their task or special purpose.

d) Temporary parking of moving vans, garbage pickup, and other service-related

e) Individual private vehicles as duly approved by the Barangay for special events of limited duration

SECTION 5. THE NEW TRAFFIC SCHEME. The new traffic scheme in Menlo Subdivision, A. Marcelo St., Dalandanan, Valenzuela City shall be as follows:

a) Two way route starting at the entry point of First St. up to the intersection of First street and Fourth St

b) One-Way route starting at the corner of Fourth St. and First St. up to the corner of First St. And Second St.

c) One-Way route at the entry of Second St. starting from the corner of First Street and Second St

d) One-Way route at the entry of Third St. starting from the corner of Second Street and Third Street.

e) One-Way route at the entry of Fourth St. starting from the corner of Third Street and Fourth Street.

f) One-Way route at the entry of Vida St. starting from the corner of Vida Street and Second Street

SECTION 6. ONE-SIDE PARKING. There shall be only twenty-three (23) slots allotted for one-side parking in Menlo Subdivision particularly in the following streets

a) Left side of First Street - seven (7) slots b) Right side of Vida Street - four (4) slots c) Left side of Second Street - three (3) slots

d) Left Side of Third Street - four (4) slots

e) Right Side Third Street cor. Second Street - one (1) slot

f) Left Side of Fourth Street - four (4) slots

SECTION 8. LIABILITY. The driver of the involved vehicle shall be responsible and liable for payment of any fine, civil penalty, or such other fees arising from the enforcement of this Ordinance. Provided the registered owner of the involved vehicle shall not be responsible if such vehicle was in the care, custody, or control of some person who did not have authority or permission of the registered owner to use the vehicle.

SECTION 9. PAYMENT OF ADMINISTRATIVE PENALTIES. – Any violation

of this Ordinance shall subject the offender driver/operator/owner to the following administrative penalties:
