Ordinance No. 1106, Series of 2023 AN ORDINANCE LIMITING THE SPEED LIMIT OF MOTORISTS, INCLUDING BICYCLES, PASSING ALONG A. MARCELO ST., BARANGAY DALANDANAN TO A MAXIMUM 20 KILOMETERS PER HOUR TO AVOID ROAD ACCIDENTS IN THE AREA.

SECTION 1. TITLE - This Ordinance shall be known as the "A. MARCELO ST., DALANDANAN SPEED LIMIT ORDINANCE".

SECTION 2. COVERAGE - This Ordinance as adapted, applies to all vehicle traversing A. Marcelo St., in Barangay Dalandanan;

SECTION 3. SPEED LIMIT- No vehicle, while traversing A. Marcelo St., shall accelerate at a speed of more than 20 KPH. Such speed limit, however, will not apply to the driver of emergency vehicles, such as but not limited to, fire trucks and ambulances, during life threatening situations.

SECTION 4. ADMINISTRATIVE PENALTY- Any person found violating this Ordinance shall be charged with an administrative penalty of:

The City Government of Valenzuela and the Dalandanan Barangay Council may acquire sufficient speed gun to be utilized by Traffic Enforcers giving priority to the areas with high reported occurrences of accidents.

The Traffic Management Division thru the Traffic Engineering and Design Unit (TEDU) is hereby tasked to provide signages in the said area.

SECTION 6. IMPLEMENTING RULES AND REGULATIONS. While this ordinance and the provisions hereof are already operative upon its effectivity, the City Mayor, may issue the appropriate and relevant rules and regulations for the proper implementation of this ordinance.

SECTION 7. REPEALING CLAUSE - All previous ordinance and issuances, rules and regulation or parts thereof which are inconsistent with the provision of this ordinance are hereby repealed or modified accordingly.
