ORDER

In a verified amended petition, petitioner Nympha Viray Juan seeks that after due notice and hearing, an Order be issued directing the Office of the Civil Registrar of San Juan City to cancel the Certificate of Live Birth issued to Airrienne Joyce Corpuz Juan under Registry No. 2003-137 and for the Local Civil Registrar of San Juan City to annotate the Judgment and Certificate of Finality in its Registry Records.

Petitioner alleges that:

- On 16 September 1985, petitioner gave birth to her first child at UERM Hospital in Quezon City whom she named Airrienne Joyce Viray Juan (Airrienne) and whose fact of birth was duly registered with the Local Civil Registrar of Quezon City under Registry No. 85-30993;
- As her child was growing up, petitioner observed and later medically confirmed that she was suffering from mental disability, hence, was unable to finish formal schooling. She was then issued PWD ID No. 13390607128 on 2 November 2022 at the City of Manila and has been under the special home care of petitioner's elder sister, Evella F. Viray (Evella);
- On the basis of her Certificate of Live Birth, Airrienne, assisted by Evella, applied for and was issued on 28 July 2011 a Philippine Passport which Airrienne used when she traveled to Singapore and Malaysia in October 2012;

- The passport was renewed and the new passport was valid until 12 April 2021;
- Before the expiration on 12 April 2021, petitioner requested Evella to have Airrienne's passport renewed but upon verification, the DFA explained that the issuance of the renewed passport was blocked or held in abeyance due to an information appearing in the DFA records of the existence of a "double passport" issued to na assumed name "Airrienne Joyce Corpuz Juan";
- Upon recollection, petitioner remembered that sometime in 2008, due to her eagerness and hurry to then secure Airrienne's passport for future travel plans though with mental deficiency, she was duped and became a victim of an unscrupulous scam agent whom she met at the City Hall of Manila who introduced herself as having good connections at the DFA;
- This impostor assured her that she can get a special passport in a very short time and suggested to use the assumed name of "Airrienne Joyce Corpuz Juan" by using a late registration of birth scheme. Being naive, unsuspecting, and unlearned, she fell to the scheming trap of this unscrupulous agent whose name she could no longer recall;
- Sometime in 2008 the scam agent presented to her the promised passport but immediately disappeared thereafter;
- Petitioner had no deliberate intention or willful desire to violate or transgress any of the Philippine laws and regulations or government policies.

WHEREFORE, set the petition for hearing on **13 December 2023 at 8:30 o'clock in the morning** before this Court located at Branch 160, Fourth Floor, The New Hall of Justice, San Juan City, Metro Manila. The Office of the Solicitor General shall appear at the hearing on behalf of the government. Any interested person who opposes the petition may likewise appear.

Publish a copy of this Order at the expense of the petitioner once a week for three (3) consecutive weeks in a newspaper of general circulation in Metro Manila to be selected by raffle.

Furnish the petitioner, the Office of the Solicitor General, Local Civil Registrar of San Juan City, the Civil Registrar General- Philippine Statistics Authority, and all persons affected thereby, copies of the Petition and its annexes, and this Order.
