ORDER

This is a verified Petition filed on August 14, 2023 by petitioner Jocelyn H. Domingo, for Settlement of the Intestate Estate of Dante Fung; Accounting, and Issuance of Letters of Administration.

The Petition alleges that:

- 1) The petitioner is a former employee of Dante Fung at Sto. Niño Panciteria, 415 JP Rizal St. Sto. Niño Marikina City;
- 2) On April 1, 2011, the Department of Labor and Employment rendered a Decision, the dispositive portion of which ordered Dante Fung and/or Sto. Niño Panciteria to pay the petitioner and Benilda Valdez the aggregate amount of Four Hundred Eighty Thousand Five Hundred Two (Php480,502.00) Pesos;
- 3) On November 19, 2012, a Writ of Execution for the said case was issued and the real property of Dante Fung with Transfer Certificate of Title No. 235509 was levied on execution. A failure of public execution was declared after no bidders participated in the auction sale. An encumbrance was then issued and attached to TCT No. 235509;
- 4) The petitioner likewise filed a complaint for illegal dismissal, underpayment of wages, and other money claims against before the National Labor and Relations Commission (NLR) against Sto. Niño Panciteria, Dante Fung, and his siblings. The NLR rendered a Decision, the dispositive portion of which declared Sto. Niño Panciteria and Dante Fung to be solidarily liable to pay the petitioner in the amount of One Hundred Ninety-Nine Thousand Five Hundred Seventy-Six Pesos (Php199,576.00). The said award is separate from the previous award in the amount of Php480,502.00;
- 5) A Writ of Execution for the said award was issued on June 19, 2012. A subsequent Writ of Execution was issued on June 1, 2015;
- 6) On January 26, 2013, Dante Fung died;
- 7) After a considerable lapse of time and the execution not having been satisfied, the petitioner filed another Complaint for illegal dismissal and money claims against Sto.   - D. Cristina B. Fung (niece of Dante Fung with his deceased brother Rolando Fung), of legal age, and residing at 415 J.P. Rizal St., Brgy. Sto. Niño, Marikina City;
  - E. Rolando B. Fung, Jr. (nephew of Dante Fung with deceased brother Rolando Fung), of legal age and residing at 415 J.P. Rizal St., Brgy. Sto. Niño, Marikina City;

- 12) The gross market value of the said property is estimated to be in the amount of Three Million Seven Hundred Eighty-Five Thousand Pesos (Php3,785,000.00) and a combined assessed value of One Million Eight Hundred Ninety-Two Thousand and Five Hundred Pesos (Php1,892,500.00);
- 13) Since the total assessed value is Php1,892,500.00, the assessed value per square meter is Php5,114.86 (Php1,892,500.00 divided by 370sqm.);
- 14) Thus, multiplying the said assessed value per square meter to the 74 sqm. share of Dante Fung in the subject property, the assessed value of the share of Dante Fung in the said property, which forms part of his estate, is Php378,499.64;
- 15) The petitioner thus instituted the instant case for the issuance of letters administration to a competent person to make a full inventory and accounting of his estate, administer such estate, and settle any or all claims for and against such estate during the pendency of the estate proceedings prior to the distribution of the net estate to the compulsory heirs;
