043 in relation to No. 2020-069 (re: Guidelines
in conduct of on-line hearing during community
quarantine), the Formal Offer of Evidence
(FOE) must be submitted at least FIVE (5) work-
ing days prior to the scheduled hearing.

Parties opposed to the granting of the applica-
tion must file their written oppositions
supported by documentary evidence on or
before the above date furnishing a copy of
the same to the applicant/s and may if they
so, desire appear on said date and time.

This application will be acted upon by this
Board on the basis of its records and documen-
tary evidence submitted by the parties, unless
the Board deems it necessary to receive addi-
tional documentary
