ORDER

In a verified Petition for Declaration of Absolute Nullity of Marriage under Art. 36 of the Family Code for Psychological Incapacity, petitioner prayed that a judgment be issued declaring the marriage between the petitioner and respondent as void ab initio by reason of psychological incapacity attendant in the marriage; ordering the cancellation of the Certificate of Marriage issued by the Civil Registrar's Office; and other remedies just and equitable under the law.



AMENDED ORDER

In a verified petition, petitioner Vinche Julia Kintanar alleges that:
1. Petitioner is of legal age, Filipino, and a resident of Bacaca, Brgy. 19-B, Poblacion District, Davao City;
2. Respondent is a Japanese national with last known address at 378-1, Hirata-cho, Hikone City, Shiga, Japan;
3. Petitioner and private respondent were married on 16 October 2002 at a Christian Church in 54-B, F. Santiago St., San Juan, Metro Manila, Philippines;

4. The marriage between them was valid and was also registered in Japan;
5. Due to serious problems in their marriage, private respondent filed for divorce against petitioner. Parties were then divorced in accordance with Japanese law on 26 February 2007;
6. Divorce under Japanese law capacitates private respondent to remarry;
7. Private respondent was able to marry a certain Rowena Marquez Velasco on 14 May 2008 who he divorced on 21 February 2011 and a certain Stephanie May Reyes Santos on 23 May 2011.
Petitioner prays that after due notice and hearing, a Decision be issued:

1. Recognizing the Foreign Divorce of Shinichi Tanaka and Vinche Julia Kintanar on 26 February 2007 in Japan as valid;
2. Declare the marital bond between the parties severed as a result thereof and declaring petitioner capacitated to remarry;
3. Ordering the Civil Registrar General-Philippine Statistics Authority and the Local Civil Registrar of San Juan City to annotate the divorce decree on the Certificate of Marriage of the parties; and,
4. Ordering the local civil registrar to register and record the judgment (recognizing the divorce).

AMENDED
ORDER

Before this Court is a Petition for Judicial Recognition of Foreign Judgment of Divorce filed by the petitioner through her counsel, Atty. Ferdinand S.
