DECLARATION OF NULLITY OF MARRIAGE UNDER ART. 36 OF THE FAMILY CODE

### ORDER

In a verified Petition for Declaration of Absolute Nullity of Marriage under Art. 36 of the Family Code for Psychological Incapacity, petitioner prayed that a judgment be issued declaring the marriage between the petitioner and respondent as null and void *ab initio* pursuant to Article 36 of the Family Code, due to the psychological incapacity of petitioner and respondent and unable to fulfil their marital obligations and such other reliefs and remedies, just and equitable under the circumstances.

The Petition states that respondent's last known address is at **Al-Hili 3<sup>rd</sup> Street, 5<sup>th</sup> House Flat 1, Al Ain, Abu Dhabi, United Arab Emirates.** As a result, a Motion for Extraterritorial Service of Summons with Leave of Court was filed by petitioner and is hereby GRANTED.

WHEREFORE, upon Leave of Court, let this Order be published once a week for two (2) consecutive weeks in a <u>newspaper of general circulation in the Philippines</u>. In addition, a copy of the Summons and Order of the Court shall be served to the respondent by registered mail at 9-D, Masikap Street, Barangay Piñahan, Quezon City, her last known address in the country.

Within THIRTY (30) DAYS from the last issue of the publication, respondent is directed to file her Answer.
