ORDINANCE NO. 1168, Series of 2024 AN ORDINANCE REGULATING THE USE OF STEEL PLATES DURING CONSTRUCTION, EXCAVATION, REPAIR, AND MAINTENANCE OF ROADS WITHIN THE TERRITORIAL JURISDICTION OF VALENZUELA CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

SECTION 1. TITLE, Xxxxxxxxxxx SECTION 2. COVERAGE. XXXXXXXXXX

SECTION 3. DEFINITION OF TERMS. XXXXXXXXXX

SECTION 4. TEMPORARY USE OF STEEL PLATES – In order to promote safety to the motorists and the general

public, the following mandatory requirements and regulations for the temporary use of steel plates shall be observed:

a. MARKING WITH DURABLE and HIGHLY REFLECTIVE PAVEMENT TAPE or PAINT - Temporary steel plates installed on roadways open to vehicular traffic should be marked with a durable and highly reflective white payement marking tape no less than 4 inches in width.

b. COATING OF NON SKID and RUST INHIBITIVE PRODUCT- Temporary steel plating and street bridging shall be coated with a non-skid and rust inhibitive product. Examples of non-skid steel plating are surfaces with waffle patterns or right angle or right angle undulations.

c. NO EDGES STUCKING UP INSTALLATION - Plating shall be installed with no edges or corners stucking up and shall be installed, secured and maintained in a way that will prevent the plate from bouncing, shifting and moving vertically or horizontally. Plates shall be secured against shifting by tack welding, wedges, adjustable cleats, shims, fasteners or other appropriate devices. Transitions shall be installed with hot-patched asphalt concrete.

d. FLUSH OR TRANSITIONED WITH THE SIDEWALK- Plates shall be flush or transitioned with the sidewalk.

roadway and other portions of the public right of way. Whenever the grade difference between the existing pavement and the excavated area is greater than \(^{3}\) inch, longitudinal and transverse transitions with a maximum slope of 1:18 shall be provided. Transitions shall be installed with hot-patched asphalt concrete.

e. STEEL PLATE TYPE - The type of steel plate to be used should take into account traffic speed, traffic volume, and composition, duration and dimension of the proposed excavation, and weather conditions. Typical steel plate bridging used within the City are A-36 grade steel, designed for H520-44 loads, which extend a minimum of 12 inches beyond the edges of the trench and have a plate thickness of 1 inch.

SECTION 5. MAINTENANCE OF TEMPORARY STEEL PLATES. Public utility companies or contractors are responsible for maintaining temporary steel plates and ensuring a safe and adequate path of travel for all vehicles, motorists, and pedestrians. Trenches shall be adequately shored to support the bridging and traffic loads. It shall conduct

SECTION 6. TWO (2) MONTHS MAXIMUM PERIOD TO USE TEMPORARY STEEL PLATES. The temporary use of steel plates shall not exceed two (2) months for construction, excavation, repair, and maintenance of roads within Valenzuela City.

SECTION 7. SIGNAGES. Reflective warning signs advising motorist that they should expect to encounter steel plates shall be placed at approximately:

i) first signage - 50 meters from the steel plate

ii) second signage - 10 meters from the steel plate

Further, the distance of the signages may vary in case the installed steel plates are adjacent to each other. Steel plates left overnight may require, at the discretion of the City Engineering Office, that the sign be supplemented with a lowintensity-flashing warning light mounted on the sign support.

SECTION 8. DESIGNATION OF FOCAL PERSON. The public utility company or contractor shall designate at least one (1) focal person to check, assess, and monitor the installed temporary steel plates in every barangay. Such focal person may be designated in a certain barangay and/or clustered barangay and he/she shall report at least twice a day, anytime in the morning and afternoon as to the status and condition of its steel plates.

SECTION 9. APPLICATION OF PERMIT. The public utility company or contractor shall apply a permit to the City Engineering Office for the temporary use of steel plates for excavation, repair, and maintenance of road in Valenzuela City. The permit allows the public utility company or contractor hired by the company to conduct the work within the road. The approval of the City Engineering Office is required prior to the temporary use of steel plates for construction, excavation, repair, and

Further extension of the use of steel plates shall require a justifiable reason/s stated in a written request letter to warrant the grant of additional period. **SECTION 10. EXISTING STEEL PLATES.** Within two (2) months from the approval of this Ordinance, all existing

steel plates installed, laid, or placed in all roads within the City of Valenzuela shall comply to the requirements and regulations set forth in this ordinance.
SECTION 11. LIABILITY IN CASE OF DAMAGE TO PROPERTY, INJURY OR DEATH. The public utility

company or contractor shall be liable to any accident which may cause damage to property, injury or death to any person by reason of defective steel plate, improper installation or violation of this ordinance.

SECTION 12. ADMINISTRATIVE PENALTIES. The Public Utility Company or Contractor's President, General

Manager, Owner, Area Manager, Supervisor and the person/s who directly construct/s or install/s steel plates which cause the damage shall be meted with the following administrative penalties:

Nature of Offense	Administrative Penalties	
1st Offense	Fifty Thousand Pesos (Php 50,000.00)	
2nd Offense	One Hundred Thousand Pesos (Php 100,000.00)	
3rd Offense Two Hundred Thousand Pesos (Php 200,000.00) and ban from doing business in the City of Valenzuela		

The imposition, assessment and collection of administrative penalty is without prejudice to the filing of a criminal action against the offender/s if so warrants.

SECTION 13. PENAL CLAUSE. The Public Utility Company or Contractor's President, General Manager, Owner Area Manager, Supervisor and the person/s who directly construct/s or install/s steel plates which cause the damage shall be fined in the amount of Five Thousand Pesos (Php 5,000.00) or imprisonment for a period of one (1) year, or both subject to the discretion of the Court.
