

ORDINANCE NO. 1175, Series of 2024

AN ORDINANCE AMENDING ORDINANCE NO. 1052, SERIES OF 2022, ENTITLED "AN ORDINANCE PRESCRIBING THE GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN SCHOOLS AND WORK IN SCHOOL AND COLLEGES IN THE EVENT OF DISASTERS AND OTHER NATURAL CALAMITIES IN THE CITY OF VALENZUELA", AND OTHER PURPOSES.

SECTION 1. Section 4 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows: **"SECTION 4. DEFINITION OF TERMS.-**

Dangerous Heat Index - refers to heat index reaching forty-two degrees Celsius (42°C) to fifty-one degree Celsius (51°C) as forecasted by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) based on its nearest monitoring site from Valenzuela City which is located at PAGASA SCIENCE GARDEN STATION.

Disaster - refers to a serious disruption of the functioning of a community or society involving widespread human, material, economic, or environmental losses and impacts, which exceeds the ability of the affected community or society to cope using its own resources. Disaster is often described as a result of the combination of: the exposure to a hazard; the conditions of vulnerability that are present; and insufficient capacity or measures to reduce or cope with the potential negative consequences. Disaster impacts may include loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption, and environmental degradation.

Heat Wave - for purposes of this Ordinance, it refers to the prolonged period of excessive heat with a temperature of fortytwo degree Celsius (42°C) or above.

Heat Index - a measure indicating the level of discomfort the average person is thought to experience as a result of the combined effects of the temperature and humidity of the air as determined by PAG-ASA.

Natural Calamity - means earthquake, fire, typhoon/storm, flood, landslide, heavy rain, drought, famine, epidemic, heat wave and other similar natural disaster which also includes the industrial accident or accident caused by explosions or poisoning and any other kinds of disaster.

School Head - shall refer to the person responsible for the administrative and instructional supervision of the school or cluster of schools such as the Principal, President, or Administrator." SECTION 2. Section 5 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows:

"SECTION 5. GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN PUBLIC AND PRIVATE PRE-SCHOOL, ELEMENTARY, AND SECONDARY LEVELS & COMMUNITY LEARNING CENTERS.

5.1. The following guidelines shall be followed for the automatic cancellation or suspension of classes and work in one, some or all public and private schools in the City of Valenzuela in conformity with DepEd Order No. 37, Series of 2022:

5.2. In case of heat wave, upon reaching dangerous heat index which is at least forty two degrees Celsius (42°C) or above, inperson classes and work shall immediately be cancelled or suspended. However, classes shall be conducted through online synchronous or asynchronous modes of learning subject to the reasonable discretion of the school head.

In case of extreme heat index below forty-two degrees Celsius (42°C), the local chief executive and/or the school head upon reasonable assessment and in coordination with appropriate government offices/agencies, may declare cancellation or suspension of in-person classes and work, without prejudice to the reasonable discretion of the school head to conduct classes through online synchronous or asynchronous modes of learning.

a) Classes in one, some or all levels in public and private schools as well as work in schools may be cancelled or suspended by the Local Chief Executive, such as but not limited to floods or inundations, earthquakes, conflagration, extreme heat wave, and other disasters and calamities, upon recommendation of the Valenzuela Disaster Risk Reduction Management Council (VDRRMC) in order to prevent loss of lives and limbs.
