ORDINANCE NO. 1178, Series of 2024

AN ORDINANCE PROHIBITING THE DETENTION OF INDIVIDUALS AND CADAVERS IN HOSPITALS, MEDICAL CLINICS, OR ANY OTHER SIMILAR FACILITIES, AND FAILURE OR REFUSAL TO ISSUE BIRTH CERTIFICATES OR DEATH CERTIFICATES ON THE GROUND OF NON-PAYMENT OF HOSPITAL BILLS OR MEDICAL EXPENSES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES.

GENERAL PROVISIONS
SECTION 1. PURPOSE AND COVERAGE - This Ordinance, which shall be known as the VC ANTI-HOSPITAL DETENTION ORDINANCE, is hereby promulgated for purposes of prohibiting and penalizing detention of individuals and candavers in Health Care Facilities, and failure or refusal to issue birth certificates or death certificates on the sole ground of non-payment of Health Care Fees.

This Ordinance shall be implemented in all Health Care Facilities situated and operating within the territorial jurisdiction of Valenzuela City. SECTION 2. DEFINITION OF TERMS XXXXXXXXXXXXXXXXX

PROHIBITION ON DETENTION OF PATIENTS AND/OR PATIENT REPRESENTATIVES

SECTION 3. PROHIBITED ACTS - It shall be unlawful for any Health Care Institution or Health Care Worker to detain or to otherwise cause, directly or indirectly the detention of a Patient and/or Patient Representative, as defined and under the circumstances in Sections 2(A) and 2(B) of this Ordinance.

SECTION 4. OPTIONAL NOTICE OF VIOLATION AND DEMAND TO RELEASEDETAINED INDIVIDUAL - Any person, including, but not limited to, the Patient himself or Herself, Patient Representative, any public officer, officer of the law, or a representative from the Valenzuela City Social Welfare Development Office or the Office of the City Mayor, may make a written notice and demand to the Health Care Institution or Health Care Worker, as the case may be, which may include the following:

i. The name/s of the Patient of Patient Representative, the fact of detention, and commencement thereof; ii. The Health Care Institution or Health Care Worker directly or indirectly involved in the detention of the Patient or Patient Representative;

iii. Attachment of an originally signed and notarized promissory note executed by the Patient, or in case of a deceased Patient, the Patient Representative, undertaking to pay the unpaid Health Care

Fees, in compliance with Republic Act No. 9439; and
iv. Demand to release the Patient, Patient's cadaver, or Patient Representative, as the case may be, within three (3) hours from personal service of the written notice and demand to the Health Care Institution or Health Care Worker.

In case of corporations, partnerships, or cooperatives, the written notice and demand shall be addressed to Health Care Institution Corporate Officers of the Health Care Institution, whose individual names need not be indicated in the written notice and demand.

For purposes of this Ordinance, service of the written notice and demand to any security guard on actual duty at the time of service of such notice, or any other Health Care Institution personnel who

has the apparent authority or customary duty to receive written notices, communications, and letters, shall constitute sufficient compliance with Section 4 hereof.

In case of failure to comply with the written notice and demand, the addressee thereof, whether the partner, chairman of the board, president, general manager, branch manager, board of directors, and/ or medical director of the Health Care Institution, shall be personally liable for the administrative and penal sanctions as defined in Article IV hereof.

Provided, however, that the execution and service of the written notice and demand shall not be a requirement to impose penal and administrative sanctions on Health Care Institutions and/or Health Care Workers who may directly or directly detain Patients and/or Patient Representatives, as provided in Section 3 hereof

PROHIBITION ON NON-ISSUANCE OF DEATH CERTIFICATE

SECTION 5. PROHIBITED ACTS - It shall be unlawful for any Health Care Institution, or Health Care Worker to refuse to issue or withhold the issuance of a birth certificate or death certificate to a Patent or Patient Representative on the sole ground of non-payment of Health Care Fees, provided the Patient or Patent Representative executes and submits a notarized promissory note in favor of the relevant Health Care Institution and/or Health Care Worker, in compliance with Republic Act No. 9439.

SECTION 6. OPTIONAL NOTICE OF VIOLATION AND DEMAND TO ISSUE CERTIFICATES - The nearest surviving relative of the Patient, may make a written notice and demand to the Health Care

Institution or Health Care Worker, as the case may be, which may include the following:

i. The name/s of the Patient, the fact of birth or death, as the case may be, and the date thereof;
ii. The Health Care Institution or Health Care Worker obligated under the law to sign and issue the birth certificate or death certificate, as the case may be;
iii. Attachment of an originally signed and notarized promissory note executed by the Patient, or in case of a deceased Patient, the Patient Representative, undertaking to pay the unpaid Health Care Fees, in compliance with Republic Act No. 9439; and

iv. Demand to issue the birth certificate or death certificate, as the case may be, within three (3) working days from personal service of the written notice and demand to the Health Care Institution or Health Care Worker.

In case of corporations, partnerships, or cooperatives, the written notice and demand shall be addressed to Health Care Institution Corporate Officers of the Health Care Institution, whose Individual names need not be indicated in the written notice and demand.

For purposes of this Ordinance, service of the written notice and demand to any security guard on actual duty at the time of service of such notice, or any other Health Care Institution personnel who

has the apparent authority or customary duty to receive written notices communications, and letters, shall constitute sufficient compliance with Section 6 hereof.

In case of failure to comply with the written notice and demand, the addressee thereof, whether the partner, chairman of the board, president, general manager, board of directors, and/or medical director of the Health Care Institution shall be personally liable for the administrative and penal sanctions as defined in Article IV hereof.

Provided, however, that the execution and service of the written notice and demand shall not be a requirement to impose penal and administrative sanctions on Health Care Institutions and/or Health Care Workers who refuse to issue or withhold the issuance of a birth certificate or death certificate to a Patient or Patient Representative, as provided in Section 5 hereof.

SECTION 7. MANDATE TO ISSUE DEATH CERTIFICATE OR BIRTH CERTIFICATE - For Births and deaths occurring prior to the effectivity of this Ordinance and for which certificates have yet to be

issued on the sole ground of non-payment of Health Care Fees, Health Care Institutions and Health Care Workers are hereby mandated to issue the appropriate death certificates and birth certificates to all their respective Patients or Patient Representatives within ninety (90) calendar days from the effectivity of this Ordinance.

Provided, however, Patients or Patient Representatives who shall avail of their rights under this Section 7 must execute and submit a promissory note in favor of the relevant Health Care Institution

and/or Health Care Worker, in compliance with Republic Act No. 9439.

ARTICLE IV PENALTIES

SECTION 8. ADMINISTRATIVE PENALTIES - Health Care Institutions, Health Care Institution Corporate Officers, or Health Care Workers who shall violate the prohibited acts as defined in this Ordinance shall be meted with the following penalties:

Nature of Offense	Administrative Penalty
1st Offense	Two Hundred Thousand Pesos (PhP 200,000.00) or suspension of business permit for thirty (30) calendar days, or both, upon the discretion of the City Mayor. The City Mayor may lift the suspension of business permit upon satisfactory remediation of the act complained of.
2nd Offense	Three Hundred Thousand Pesos (PhP 300,000.00) or suspension of business permit for sixty (60) calendar days, or both, upon the discretion of the City Mayor. The City Mayor may lift the suspension of business permit upon satisfactory remediation of the act complained of.
3rd and Subsequent Offenses	Four Hundred Thousand Pesos (PhP 400,000.00) or suspension of business permit or both, upon the discretion of the City Mayor. The City Mayor may lift the suspension of business permit upon satisfactory remediation of the act complained of.

Health Care Institutions, Health Care Workers, and Health Care Institution Corporate officers who may be found liable under this Section 8 shall be jointly and severally liable to pay the administrative

AN ORDINANCE AMENDING ORDINANCE NO. 1052, SERIES OF 2022, ENTITLED "AN ORDINANCE PRESCRIBING THE GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN SCHOOLS AND WORK IN SCHOOLAND COLLEGES IN THE EVENT OF DISASTERS AND OTHER NATURAL CALAMITIES IN THE CITY OF VALENZUELA", AND OTHER PURPOSES.

SECTION 1. Section 4 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows: "SECTION 4. DEFINITION OF TERMS.-

Dangerous Heat Index - refers to heat index reaching forty-two degrees Celsius (42°C) to fifty-one degree Celsius (51°C) as forecasted by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) based on its nearest monitoring site from Valenzuela City which is located at PAGASA SCIENCE GARDEN STATION.

Disaster - refers to a serious disruption of the functioning of a community or society involving widespread human, material, economic, or environmental losses and impacts, which exceeds the ability of the affected community or society to cope using its own resources. Disaster is often described as a result of the combination of: the exposure to a hazard; the conditions of vulnerability that are present; and insufficient capacity or measures to reduce or cope with the potential negative consequences. Disaster impacts may include loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption, and environmental degradation.

Heat Wave - for purposes of this Ordinance, it refers to the prolonged period of excessive heat with a temperature of forty-

two degree Celsius (42°C) or above.

Heat Index - a measure indicating the level of discomfort the average person is thought to experience as a result of the

combined effects of the temperature and humidity of the air as determined by PAG-ASA.

Natural Calamity - means earthquake, fire, typhoon/storm, flood, landslide, heavy rain, drought, famine, epidemic, heat wave and other similar natural disaster which also includes the industrial accident or accident caused by explosions or poisoning and any other kinds of disaster.

School Head - shall refer to the person responsible for the administrative and instructional supervision of the school or

cluster of schools such as the Principal, President, or Administrator."
SECTION 2. Section 5 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows:
"SECTION 5. GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN PUBLIC AND PRIVATE PRE- SCHOOL, ELEMENTARY, AND SECONDARY LEVELS & COMMUNITY LEARNING CENTERS.

5.1. The following guidelines shall be followed for the automatic cancellation or suspension of classes and work in one, some or all public and private schools in the City of Valenzuela in conformity with DepEd Order No. 37, Series of 2022:

b) Heavy Rainfall

c) Flood

d) Earthquakes

5.2. In case of heat wave, upon reaching dangerous heat index which is at least forty two degrees Celsius (42°C) or above, inperson classes and work shall immediately be cancelled or suspended. However, classes shall be conducted through online synchronous

or asynchronous modes of learning subject to the reasonable discretion of the school head.

In case of extreme heat index below forty-two degrees Celsius (42°C), the local chief executive and/or the school head upon reasonable assessment and in coordination with appropriate government offices/agencies, may declare cancellation or suspension of in-person classes and work, without prejudice to the reasonable discretion of the school head to conduct classes through online synchronous or asynchronous modes of learning.

5.3 Maintenance of workforce and activation of DRRM Teams

SECTION 3. Section 6 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows:

"SECTION 6. - GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN STATE/LOCAL UNIVERSITIES AND COLLEGES AND PRIVATE COLLEGES/UNIVERSITIES - The following guidelines shall be followed for the automatic cancellation or suspension of classes and work in one, some or all state/local universities and colleges and private colleges/universities in the City of Valenzuela:

6.1. In case of other natural disasters or calamities not included in this Section which might jeopardize people's safety and/or properties, as duly determined by appropriate government offices/agencies or upon the local chief executive's reasonable assessment, in person classes and work shall immediately be cancelled or suspended, without prejudice to the reasonable discretion of the school head to conduct classes through online synchronous or asynchronous modes of learning.

SECTION 4. Section 7 of Ordinance No. 1052, Series of 2022, is hereby amended to read as follows:

"SECTION 7. DISCRETIONARY CANCELLATION AND REVERSION OF CANCELLATION OF CLASSES.-

a) Classes in one, some or all levels in public and private schools as well as work in schools may be cancelled or suspended by the Local Chief Executive, such as but not limited to floods or inundations, earthquakes, conflagration, extreme heat wave, and other disasters and calamities, upon recommendation of the Valenzuela Disaster Risk Reduction Management Council (VDRRMC) in order to prevent loss of lives and limbs.
