AN ORDINANCE AMENDING ORDINANCE NO. 1052, SERIES OF 2022, ENTITLED "AN ORDINANCE PRESCRIBING THE GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN SCHOOLS AND COLLEGES IN THE EVENT OF DISASTERS AND OTHER NATURAL CALAMITIES IN THE CITY OF VALENZUELA", AND OTHER PURPOSES.

"SECTION 6. - GUIDELINES ON THE CANCELLATION OR SUSPENSION OF CLASSES AND WORK IN STATE/LOCAL UNIVERSITIES AND COLLEGES AND PRIVATE COLLEGES/ UNIVERSITIES.

6.1. In case of extreme heatwave, whether heat index reaches dangerous level (at least 42°C) or not (below 42°C), in-person classes and work shall not automatically be cancelled or suspended. The local chief executive based on his/her reasonable assessment, in coordination with appropriate offices/agencies, may declare cancellation or suspension of in-person classes and work, without prejudice to the reasonable discretion of school head to conduct classes through online synchronous or asynchronous mode.

If the local chief executive does not declare cancellation or suspension of in-person classes and work, the school head based on its reasonable assessment and at its reasonable discretion, may declare cancellation or suspension of in-person classes and work without prejudice to conduct of classes through online synchronous or asynchronous mode.
