### ORDER

In a verified Petition for Declaration of Absolute Nullity of Marriage under Art. 36 of the Family Code for Psychological Incapacity, petitioner prayed that a judgment be issued declaring the marriage between the petitioner and respondent as void ab initio by reason of psychological incapacity and other remedies just and equitable under the law.
