ORDINANCE NO. 1179, Series of 2024 AN ORDINANCE ALLOWING ONE-SIDE FREE PARKINGAND ONE-WAY TRAFFIC SCHEME ALONG G. ROCIO ST., G SALAZAR ST., AND FRANCISCO ALCANAR ST., BARANGAY WAWANG PULO, VALENZUELA CITY AND **PROVIDING PENALTIES FOR** VIOLATION THEREOF.

SECTION 1. TITLE. This Ordinance shall be known and referred to as "ONE SIDE PARKING AND ONE-WAY TRAFFIC SCHEME ALONG G. ROCIO STREET, G. SALAZAR ST, AND FRANCISCO ALACANAR ST BARANGAY WAWANG PULO. VALENZUELA CITY.

SECTION 2. DEFINITION OF TERMS XXXXXX

SECTION 3. SCOPE AND COVERAGE. -3.1. The one-side parking and one-way traffic scheme shall apply to all motorists traversing through the area of G. Rocio St., G. Salazar St., and Francisco Alcanar St. Valenzuela City. A copy of the one side parking and one-way traffic scheme plan is hereto attached and marked as Annex "A" and made an integral part of this Ordinance.

3.2. This Ordnance shall not be construed to confer any right of exclusive parking to areas adjacent to private property and shall not be construed to replace private parking garages or provide additional overnight parking to already existing access to private parking; **3.3.** The free parking privilege provided herein shall only be applicable to the

vehicles of Visitors/clients/employees of Wawang Pulo 3S Center and Valenzuela City Sports Park;

3.4. The areas designated for free parking shall not, at anytime, be used for purposes of displaying a vehicle for sale, repairing vehicles for a fee, vending any goods or any other private personal or commercial purposes;

3.5. The implementation of this scheme starts from 5:00 am to 10:00 pm along G. Rocio St and G. Salazar St. (only in front of Valenzuela City Sports Park) and on a 24/7 basis along Francisco Alcanar St., except in the occurrence of disaster such as flooding, earthquake, fire and other emergency situations where the use of the road and parking is necessary. SECTION 4. EXCEPTIONS. - This Ordinance shall not apply to:

4.1. Law enforcement vehicles and emergency vehicles during the performance of its official functions;

4.2. Official City/Barangay vehicles parked for the purpose of conducting its official business, including, but not limited to, delivery of public services conduct of repair or engineering works, inspection and other analogous matters 4.3. Private vehicles when performing urgent tasks or necessity for reasons, or health, physical disability or unique hardship only for the period necessary to

accomplish their tasks or special purpose; 4.4. Temporary parking of vehicles of utility companies directly connected with repair and/or maintenance of utility services and other service related vehicles;

4.5. Individual private vehicles as duly approved by the Barangay for special events of limited duration.

SECTION 5. ENFORCEMENT.-

5.1. The enforcement of the provisions of this Ordinance shall be vested to the Barangay Deputized Task Force, in conjunction with the Public Order and Safety Office, Traffic Management Office (TMO), Task Force Disiplina, and Philippine National Police (PNP) - Valenzuela City.

5.2. This Ordinance shall not be enforceable until such time as "No Parking on this Side" signs shall have been installed in the identified roads/places by the Traffic Management Division, through the Traffic Engineering and Design Unit (TEDU) in coordination with the Barangay Wawang Pulo. **SECTION 6. LIABILITY.-**

6.1. The driver and/or registered owner of the involved vehicle shall be responsible and liable for payment of any fine, civil penalty, or such other fees in relation to enforcement procedure hereunder provided;

6.2. The registered owner of the involved vehicle shall not be responsible it such vehicle was in the care, custody or control of some person who did not have authority or permission of the registered owner to use the vehicle. SECTION 7. PAYMENT OF ADMINISTRATIVE PENALTIES. - Any violation of this Ordinance shall subject the offender driver/operator/owner

with the following administrative penalties, to wit:

a. First Offense - Fine of Five Hundred Pesos (P500.00)

b. Second Offense- Fine of One Thousand Pesos (P1,000.00)

c. Third Offense - Fine of One Thousand Five Hundred Pesos (P1,500.00)

d. Payments of said Administrative Penalty shall be made to the City Treasurer's Office upon presentation of the Parking Regulation Receipt accordingly issued to the owner/driver by the authorized or deputized City Government personnel or authorized or deputized Barangay personnel. All collection generated from this ordinance shall be used for

the maintenance of City Government facilities. SECTION 8 IMPLEMENTING RULES AND REGULATIONS. - While this Ordinance and the provisions hereof are already operative upon its effectivity the City Mayor may issue the appropriate and relevant rules and regulations fo he proper implementation of this ordinance.
