JUDGMENT ON THE PLEADING

On October 24, 2014, this Court issued a resolution in the case entitled Iglesia Ni Cristo v. Sanent Realty, Inc., Civil Case No. Q-12-70796, for Specific Performance with Damages, in favor of plaintiff and against the defendant, who were the same parties in the aforesaid case. The resolution had become final and executory on December 10, 2014. However, after the lapse of five (5) years from entry of judgment, the Resolution has yet to be executed and implemented. The execution of the resolution and the complaint filed on July 6, 2022 are not barred by the statute of limitations. Hence, this instant case for revival of judgment.

For failure to file any responsive pleading, the plaintiff filed a Motion to Declare Defendant in Default. In a resolution dated July 12, 2023, the Court granted the Motion since all the elements for a declaration of default to exist are present and proven by the plaintiff.

Consequently, Section 3, Rule 9 of the Rules of Court provides the procedure after the declaration of default, to wit:

"SEC. 3. Default: Declaration of. - xxxxx Thereupon, the court shall proceed to render judgment granting the claimant such relief as pleading may warrant, unless the court in its discretion requires the claimant to submit evidence. Such reception of evidence may be delegated to the clerk of court.

WHEREFORE, in view of the above disquisition, the Court hereby revives the judgment in Iglesia Ni Cristo v. Sanent Realty, Inc. Civil Case No. Q-12 70796 and enforces Resolution dated October 24, 2014, both rendered by this Court and reiterates its order directing the defendant, within 30 days from receipt hereof:




