ORDINANCE NO. 1208, Series of 2024 AN ORDINANCE PROVIDING A NEW TRAFFIC SCHEME COVERING THE STREETS OF G. MOLINA and ITC OF BARANGAY CANUMAY EAST. VALENZUELA CITY AND PROVIDING PENALTIES THEREOF.

SECTION 1. TITLE. This ordinance shall be known as the "An ordinance providing a new traffic scheme in Barangay Canumay East, Valenzuela City, providing penalties thereof and for other purposes"

SECTION 2. COVERAGE. All motorists, residents and non-residents traversing through the streets and/or roads of Canumay East, Valenzuela City are required to obey the new traffic scheme.

SECTION 3. THE NEW TRAFFIC SCHEME. A new Traffic Scheme in Canumay East, Valenzuela City is as follows:

a. Wide Bodied Vehicles weighing more than 4500 kg, Vehicles with a height of three (3) meters, trucks, buses and alike shall not be allowed to pass through an unnamed street locally referred to as G. Molina Street (Interior) connecting G. Molina St., and ITC covering an area of 231 meters, more or less.

b. Affected Vehicles coming from G. Molina to ITC road may take Gen. Luis Street.

c. Affected Vehicles coming from ITC to Molina may take D. Bonifacio Street.

d. A period of 45 days upon the effectivity of this Ordinance shall serve as a dry-run to familiarize the motorists, commuting public and pedestrian.

SECTION 4. EXEMPTIONS. This Ordinance shall not apply to:

a. Law enforcement vehicles and emergency vehicles;

b. Official City/Barangay vehicles;

c. Private vehicles, when performing urgent tasks or necessity for reasons of health, physical disability or unique hardship only for the period necessary to accomplish their tasks or

SECTION 5. IMPOSITION OF ADMINISTRATIVE PENALTIES. Any violation of this Ordinance shall subject the offender driver/operator/owner with the following administrative penalties, to wit:

1st Offense - **P1,000.00**

2nd Offense - P3,000.00

3rd Offense & subsequent violations - P5,000.00

Payments of said Administrative Penalty shall be made to the City Treasurer's Office upon presentation of the Ordinance Violation Receipt (OVR) accordingly issued to the owner/driver by the authorized or deputized City Government personnel or authorized or deputized Barangay personnel.

SECTION 6. IMPLEMENTING AUTHORITIES and ISSUANCE OF IMPLEMENTING RULES and REGULATIONS

a. Traffic Management Office (TMO);

b. Task Force Disiplina

Implementation shall be on 24/7 basis unless there is a need to suspend particular areas only for reasons of emergencies like fire, calamities, disasters and fiesta or special occasions.

The Barangay shall assist in the implementation of this ordinance, such as but not limited to conduct of massive information campaign and to provide traffic assistance from Barangay Tanod or Barangay staff.
