AN ORDINANCE AMENDING ORDINANCE NO. 1195, SERIES OF 2024, ENTITLED: "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY GOVERNMENT OF VALENZUELA, IN THE AMOUNT OF ONE BILLION SIX HUNDRED MILLION PESOS (P1,600,000,000.00) TO FUND THE DEVELOPMENTAL PROJECTS OF THE CITY GOVERNMENT OF VALENZUELA IN ACCORDANCE WITH THE CITY'S APPROVED LOCAL DEVELOPMENT PLAN (LDP) OR

ANNUAL INVESTMENT PROGRAM (AIP) SUCH AS ACQUISITION OF MEDICAL EQUIPMENT, ICT EQUIPMENT AND SOFTWARE, FURNITURE AND FIXTURE, LABORATORY TOOLS, TECHNICAL AND SCIENTIFIC EQUIPMENT AND OTHER VARIOUS EQUIPMENT; INFRASTRUCTURE GOVERNMENT BUILDING AND FACILITIES; AND ACQUISITION/EXPROPRIATION OF LAND; AND TO AUTHORIZE THE CITY MAYOR TO NEGOTIATE, BORROW AND OBTAIN LOANS FOR THE CITY GOVERNMENT OF VALENZUELA WITH THE LAND BANK OF THE PHILIPPINES (LANDBANK) AND CONFIRMING, APPROVING AND RATIFYING ALL PREVIOUS REPRESENTATIONS, ACTS AND WARRANTIES, AND ALL THE TERMS AND CONDITIONS OF THE LOAN.

SECTION 1. AMENDMENT TO THE TITLE.
