ORDINANCE NO. 1215, Series of 2024
AN ORDINANCE MANDATING FOOD AND BEVERAGE OUTLETS/VENDORS IN VALENZUELA CITY TO SERVE ICE FROM PURIFIED WATER TO CUSTOMERS, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Authored by: **Coun. CRISTINA MARIE FELICIANO-TAN**

SECTION 1. TITLE. This ordinance shall be known as the "Ice from Purified Water Ordinance".
SECTION 2. COVERAGE. This shall apply to all cafeterias, restaurants, eateries, bistros, cafes, food stalls, catering services, convenient stores, sari-sari stores, ambulant vendors, and other related establishments serving food and/or beverages with ice, operating within the territorial jurisdiction of Valenzuela City.

SECTION 3. PURPOSE.

SECTION 4. DEFINITIONS.

SECTION 5. REQUIREMENTS FOR ESTABLISHMENTS.

All food and beverage outlet vendors and ambulant vendors in Valenzuela City that serve beverages and/or food with ice to customers are mandated to use ice made from purified water. The establishments shall ensure that the ice used in their beverages and/or food is safe for consumption and free from contaminants.

They should acquire Certificate of Water Potability from source of ice certifying that they use purified water in ice production.

This certification must be readily available in the business area upon inspection of City Health Department, or may be included as requirement in acquiring Sanitation Permit.

SECTION 6. IMPLEMENTING GUIDELINES.

1. The City Health Department shall oversee the implementation of this ordinance and conduct a regular inspections of establishments to ensure compliance.
2. Establishments found to be non-compliant with the requirement to use ice from purified water shall face penalties, including fines and suspension of operations until compliance is achieved.
3. The Valenzuela City Health Department, in coordination with Task Force Disiplina, Business Permits and Licensing Office, and other concerned offices shall provide guidelines and assistance to establishments on how to produce and store ice from purified water.
4. The City Health Department shall be the primary implementer of this ordinance and have the authority to suspend or revoke business permits of the establishments, which are to have violated this ordinance.
5. This ordinance is self-explanatory upon due publication. However, the City Mayor or his duly deputized authority is hereby authorized to issue additional guidelines and directives to effectively implement the mandate of this ordinance, if found necessary.

SECTION 7. ADMINISTRATIVE PENALTIES. Any individual who shall violate Section 5 of this Ordinance shall suffer the following penalties:

Nature of Offense	Administrative Penalty
1st Offense	One Thousand Pesos(P1,000.00)
2nd Offense	Three Thousand Pesos (P3,000.00)
3rd Offense	Five Thousand Pesos (P5,000.00)

Any corporation, association, partnership or any juridical person operating within the territorial jurisdiction of Valenzuela City found violating Section 5 of this Ordinance shall be meted with the following penalties:

Nature of Offense	Administrative Penalty
1st Offense	Five Thousand Pesos(P5,000.00)
2nd Offense	Ten Thousand Pesos (P10,000.00)
3rd Offense	Fifteen Thousand Pesos (P15,000.00) and revocation of business permit and its operation.
