Purpose. - The City Government of Valenzuela needs to strengthen its disaster response during calamities to ensure the well-being and safety of its constituents, thus, a need to realign the funds previously appropriated for the purchase of TM Tactical Shelter and appropriate the same for the purchase of three (3) units of drone, two (2) units of rubber boats, and two (2) units of Starlink Internet.
