straining Order. On 18 January 2023, complainants filed a Complaint with application for issuance of Temporary Restraining Or-der (TRO) and Writ of preliminary Injunction pursuant to En Banc Resoluion No. 8 Series of 2021. Rule 17 of the Rules of Procedure of the Human Settle ments Adjudication Commission (HSAC).

A review of the allegations reveal that the complaint failed to show that, if left unrestrained, respondents' acts will cause irreparable damage and injury upon the complainant-applicant before he matter can be heard on notice.

WHEREFORE, finding the complainant's application for a TRO not impressed with merit, the application for Temporary Restraining Order is hereby **DENIED.**

Also, respondents are hereby ordered to file their comment/opposition to the complainants' application for the issuance of a <u>Writ of Preliminary Injunction</u> within <u>five (5) days</u> from the receipt hereof, copy furnished the complainants. 




