Section 1. Title. This Ordinance shall be known as the "VALENZUELA CITY CHILD PROTECTION POLICY Ordinance;

**Section 3. Implementing Agency.** The Human Resource Management Office (HRMO) of Valenzuela City is hereby designated as the implementing agency of this Ordinance, in coordination with the CSWDO and Child Protection Center. Section 4. Roles and Responsibilities of the Human Resource Management Office. The HRMO shall: (1) oversee the implementation of the Child Protection Policy; (2) Conduct regular training sessions on child protection standards for employees and relevant stakeholders; (3) Monitor compliance with the policy within all city departments and offices; (4) Establish and maintain an efficient system for reporting, addressing and resolving complaints or violations related to child protection; (5) Submit regular reports to the Sangguniang Panlungsod on the status of policy implementation and any issues or recommendations for improvement;

Section 5. Duty of All Employees. All Valenzuela City Government employees shall: (1) Abide by the Child Protection Policy and ensure that their action support a safe and protective environment for children; (2) Report any instances or suspicion of child abuse, neglect or exploitation to the designated authorities within HRMO for prompt action; (3) Participate in training sessions and workshops organized by the HRMO related to child protection:
