# AUTHORITYTO CONFISCATE TAMPERED, EXPIRED, FORGED OR FALSIFIED PWD AND SENIOR CITIZEN IDENTIFICATION CARDS

Section 3. AUTHORITY TO CONFISCATE IDENTIFICATION CARDS – Commercial establishments are hereby authorized to confiscate PWD and Senior Citizen Identification Cards whenever presented for use or availment of benefits in any of the following instances

- i. The identification card on its face bears conspicuous and apparent tampering;
- ii. The validity of the identification card has expired or terminated;
- iii. The identification card is not in the form, configuration, and appearance as prescribed and issued by the CSWDO;
- iv. The possessor of the identification card has not presented any written authorization from the indicated owner thereof to use the PWD or Senior Citizen Identification Card; or
- v. In instances when the Commercial Establishment has a Data Sharing Agreement with the City Government of Valenzuela, it has been determined that the identification card has been forged or falsified.

The confiscating commercial establishment must deliver physical possession of all confiscated PWD and Senior Citizen Identification Cards to the CSWDO within three (3) business days from the date of confiscation and shall submit the following information:

- i. Name and address of the commercial establishment;
- ii. Date and place of confiscation of PWD and Senior Citizen Identification Card;
- iii. Name and designation of the commercial establishment's Personal Information Controllers (PICs) and Personal Information Processor (PIPs); and
- iv. Reason for confiscation of PWD and Senior Citizen Identification Card.

The CSWDO shall maintain a registry of all confiscated PWD and Senior Citizen Identification Cards and the circumstances thereof pursuant to Section 3 hereof.

ORDINANCE NO. 1232, Series of 2024 AN ORDINANCE MANDATING FAST FOOD CHAINS TO PROVIDEEMPLOYMENT TO QUALIFIED SENIOR CITIZENS AND PERSONS WITH DISABILITY (PWD) RESIDENTS OF THE CITY OF VALENZUELA IMPOSING PENALTIES FOR NON COMPLIANCE THEREOF, AND FOR OTHER PURPOSES.

SECTION 1. PURPOSE AND COVERAGE. - This Ordinance is enacted to strengthen the City of Valenzuela's commitment to upholding social justice by widening employment opportunities for able and willing Senior Citizens and Persons with Disability residents of this City thereby enabling them to be self-reliant and productive members of the community. For the attainment of its purpose, this Ordinance shall apply to all fast food chains with at least three (3) branches operating within the territorial jurisdiction of the City of Valenzuela. **SECTION 2. DEFINITION OF TERMS.** 

a. Fast food chain b. Senior Citizen

c. Persons with Disability (PWD)
SECTION 3. MANDATORY EMPLOYMENT OF SENIOR CITIZENS AND PERSONS
WITH DISABILITY; TERMS OF EMPLOYMENT; WAGES AND BENEFITS. – All fast food chains with at least three (3) branches doing business in the City of Valenzuela are hereby mandated to provide for temporary employment for a period of six (6) months to willing, able, and qualified senior citizens and persons with disability (PWD). Each branch of the fast food chain shall employ at least two (2) senior citizens and one (1) PWD which total hours worked per day shall not exceed four (4) hours for at least six (6) days are working week.

days per working week.

Prospective applicants, as far as practicable, are encouraged to coordinate with the Public Employment Service Office (PESO) and undergo the necessary and appropriate pre-

Employment Service Office (PESO) and undergo the necessary and appropriate preemployment orientation (coaching).

The terms of employment of Senior Citizens and PWD shall conform to the Labor Code, as
amended, and other rules promulgated by the Department of Labor and Employment (DOLE),
especially in terms of wages, medical benefits, and insurance coverage.

Nothing in this Ordinance precludes employers from providing greater benefits and
improving conditions of work and terms of employment of Senior Citizens and PWD beyond
the minimum as provided by law and this Ordinance.

SECTION 4. PRIORITY IN EMPLOYMENT. In hiring senior citizens and PWD,
establishments are encouraged to give priority to those whose individual and family

SECTION 4. PRIORITY IN EMPLOYMENT. In hiring senior citizens and PWD, establishments are encouraged to give priority to those whose individual and family household income fall below the poverty threshold of the Philippine Statistics Authority (PSA) and those who are not recipients or grantees of any pension or retirement benefits from private or government entities. Each branch of the fast food chain shall employ at least two (2) senior citizens and one (1) PWD which total hours worked per day shall not exceed four (4) hours for at least six (6) days per working week.

SECTION 5. SAFE WORKING CONDITIONS. Senior Citizens and PWD under this Ordinance shall not be required to render any task requiring excessive physical labor or those that may pose a threat to their health, safety, and well-being.

SECTION 6. IMPLEMENTING AUTHORITY, RULES, REGULATIONS. The Office of the City Mayor, through the City Rusiness Audit Team (CRAT) and the City Social Walfare and

City Mayor through the City Business Audit Team (CBAT) and the City Social Welfare and Development Office (CSWDO) shall implement the provisions of this Ordinance.

The City Mayor may issue implementing rules and regulations for the effective implementation of this Ordinance.

SECTION 7. ADMINISTRATIVE PENALTIES. – Any natural person or juridical entity who shall violate this Ordinance shall be meted with the following administrative penalties:

a. First Offense – A fine of Five Thousand Pesos (P5,000.00) and suspension of business

operations until the rectification of the violation. b. Second Offense - A Ten Thousand Pesos (P10,000.00) and suspension of business

operations until the rectification of the violation; c. Third Offense – A fine of Fifteen Thousand Pesos (P15,000.00), revocation of Business

**SECTION 8. PENAL PROVISION.** In addition to the administrative penalties in the preceding section, any violation of this Ordinance shall be punishable by a fine of not more than Five Thousand Pesos (P5,000.00) and/or imprisonment of not more than 30 days, or

both, at the discretion of the court.
