**WHEREFORE**, let this case be set for hearing on **April 8, 2025 at 08:30 in the morning** at which date and time the respondent and other interest person may appear and showcase why the petition should not be granted and/or file his opposition thereto within fifteen (15) days from receipt of this order or from the last day of publication of this order.
